

## Know before you go!

- **Shipping:** Each customer is responsible for transporting their own products and supplies to the show. If your product is mounted in the display, you are responsible for shipping to Neu Concepts. Shipping addresses are listed beginning on page 11 of this document.
  - Returns for mounted products: Products will be removed from the booth during dismantle by show labor. You are responsible for return shipping.
- Send help for installation: You are responsible for assembling your space and setting up your product. Felicia Kelly is your on-site point of contact to answer questions.
- Send help for dismantle: You are responsible for breakdown and shipping of your product. Any items returned to Neu Concepts, will be billed for handling and storage.
- Be prepared: Bring the supplies you will need to successfully execute your space. i.e., HDMI cords, USB's, laptops. •
- Arrive a day early: It's best to arrive the day before setup to get acquainted with the setup and location of the booth.
- Meet deadlines: Please be sure to adhere to graphics and media deadlines as they are critical to booth production. If you have any questions about artwork or media files, please contact Felicia Kelly or Heather Pace.
- Product display space is prefixed: Each kiosk is prefixed with a set of services exclusively for each customer. Customer location will not be rearranged on the day of the show.


The Blues booth will be equipped with one tri-view kiosk; one customer per side. Each side provides surface and wall space to display and demonstrate product capabilities.
